Dear Ibu Shamima,


We are pleased to know that you will host a Steering Committee meeting of JRF on 1 December 2009, and are fully agree that there are number of important items to be discussed at the meeting, including the programming of remaining funds with consideration to the recent earthquake of 2 September 2009 in the Province of West Java.

We are also aware that there is a vacant position to serve as the co-Chair of Java Reconstruction Fund from the central government institution, when the mandate of the National Coordinating Team setup by the Presidential Decree Nr. 9/2006 has ended by July 3, 2008. With the intention to smoothen the coordination and implementation of the activities, we kindly propose that the position of JRF co-Chair on the Government side to be held by Bappenas, with the coordination role of the Government of Indonesia on the foreign-assisted programs for the post-disaster recovery program. This is similar to the case of Aceh and Nias, where since the BRR closure in April 2009, the role of co-Chair of the Multi Donor Fund for Aceh and Nias (MDF) has been handed over to Bappenas.


Madam,

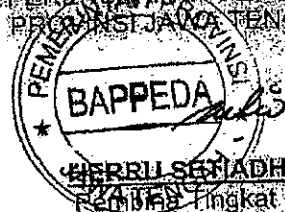
